## **Analysis of Factors Affecting Health Behaviors**

### **1: External Influences on Personal Health**

- PO 1. Analyze how the family influences the health of individuals
  - PO 2. Analyze how the culture supports and challenges health beliefs, practices, and behaviors
  - PO 3. Evaluate how peers influence healthy and unhealthy behaviors
  - PO 4. Evaluate how the school and community can impact personal health practice and behaviors
  - PO 5. Evaluate the effect of media on personal and family health
  - PO 6. Evaluate the impact of technology on personal, family, and community health

### **2: Internal Influences on Personal Health**

## **Access to Health Information, Products, and Services to Enhance Health**

### **1: Knowledge of Sources of Help**

## **Use of Interpersonal Communication Skills to Enhance Health**

### **1: Communication to Enhance Help**

**2: Application of Decision-Making Skills to Health**

- PO 1. Determine the value of applying a thoughtful decision-making process in health-related situations
  - PO 2. Justify when individual or collaborative decision making is appropriate
  - PO 3. Analyze and propose alternatives to health-related issues or problems
  - PO 4. Predict the potential short-term and long-term impact of each alternative on self and others
  - PO 5. Defend the healthy choice when making decisions
