## Structure and Origins of Government

### Types of Government

## Landmark Decisions and Historical Impact of the Court on American Government

2. Analyze the impact of landmark Supreme Court decisions on governmental powers, rights, and responsibilities of citizens in our changing society by: **JB.2**

  - c. Analyzing how the Supreme Court's decision in the case of *United States v. Nixon* (1974) impacted the separation of powers. **JB.2.C**
  - d. Analyzing how the Supreme Court's decision in the case of *Marbury v. Madison* (1803) impacted limited government and checks and balances. **JB.2.D**
  - e. Analyzing how the Supreme Court's decision in *Brown v. Board of Education* (1954) and *Baker v. Carr* (1962) impacted equal protection. **JB.2.E**
3. Evaluate the principle of due process by: **JB.3**
  - a. Explaining how the Supreme Court used the due process and equal protections clauses of the 14th Amendment to incorporate protection of individual rights and extend federal power. **JB.3.A**

## Criminal and Civil Law

    - d. Identifying the elements of criminal law including: defendant, prosecutor, reasonable doubt, felony, misdemeanor, grand jury, indictment, probable cause, presumption of innocence, plea bargaining, writ of habeas corpus, and subpoena. **JB.4.D**
    - e. Comparing the proceedings of civil and criminal cases including: grand jury, petit jury, indictment, standards of proof (beyond a reasonable doubt and preponderance of the evidence), plea bargaining, probable cause, writ of habeas corpus, and subpoena. **JB.4.E**

## Economic Policy

### Economic Systems

1. Evaluate how governments affect the answers to the basic economic questions of what to produce, how to produce, and for whom to produce by: **EP.1**
